Minutes –April 1, 2024

The Board of Commissioners of the Yolo Fire Protection District met on April 1, 2024 in a regular session at the Yolo Fire Station. Commissioner Steve Weiss called the meeting to order at 5:30 P.M.

Update on Prop 218 -Jeanette Hyson from SCI Consulting and Possible Action: Jeannette Hynson gave a presentation on the Proposed Funding Measure Survey Results. The survey was sent out to 369 property owners in the district. Items discussed were the survey objectives, the survey scope of work and methodology, the support for YFPD, the district’s projects and issues for all respondents. Also, discussed and reviewed were the survey comments, the findings and recommendations. After the review and discussion, a motion was made.
